This Memorandum of understanding (MOU) sets for the terms and understanding between Marathi Theosophical Federation,Pune (here after Known as **First Party**)and Shri Shivaji Arts and Commerce College, Amravati(Here after known as **Second Party**) to organize various activities and programs with collaboration on Universal values , Universal human Values and Ethics.)

Preamble:-

Theosophical Society is established in 1875 in America with its international headquarter at Adyar in Chennai in India. The foremost objective of the society is to form the nucleus of universal brotherhood of the people at large. It does not propose ethical coding as such .However; it has expressed and promoted certain values such as brotherhood, gender equality and social improvement. It proposes importance of certain universal human values and ethics in our lives.

Many important figures, in particular within the humanities and the arts, were influenced by teachings of theosophical society. Prominent scientists who had

belonged to the Theosophical Society included the inventor Thomas Edison, the biologist Alfred Russel Wallace, and the chemist William Crookes.

Theosophical Society, at present, has branches in almost 57 countries in the world. Head office of the country is called 'section' and the main centers in different region in the country are called federations. In India, the national head office is at Varanasi.

Theosophical teaching is extremely useful for self-development. The sister organization of theosophical society is working for helping the people who are in need of help. Social service is the main motto of this organization.

AND WHEREAS

Shri Shivaji Arts and Commerce College, Amravati is one of the important college in Amravati district of Maharashtra, bringing the stream of knowledge in the discipline of arts and commerce. From the very beginning this college has been playing a major role in providing quality education to the weaker sections and the needy citizens of this region so that they may come up as economically and socially capable class of society. In its existence of over five decades the college has produced a fairly large number of scholars, teachers, administrators, judges, advocates, political leaders, and whole generations of enlightened individuals who have enriched the society variously and are still contributing to its proper growth and development.

1. This MOU is made on / /2021 at Amravati between the Principal, Shri Shivaji Arts and Commerce College, Amravati and The President of Marathi Theosophical Federation, Pune.

2 This MOU in two copies shall come into force upon signature of both parties each party retaining one signed copy.

General terms and Condition:

1. This MOU will be valid for the period of three year from the date it becomes

effective and automatically renewed in case of extension is granted in writing with mutual consent.

2. Any change in this MOU is to be done in writing and signed by both the parties.
3. This MOU can be terminated by either party by giving 3 month notice in writing to the other party.

Cooperation –

1. This MOU is valid for three years i.e.2021-2022, 2022-2023, 2023-2024 from the date and year of agreement of the MOU between the two Parties.
2. This Collaboration is assigned to prepare the students for the Universal values like universal brotherhood, Ethics, Social responsibility and their personality development.
3. In these three years Yoga and Meditation Camp for mental strength ,Skill development activities, Study Camp on Universal values ,Essay Competition, Seminars, Workshops ,Webinar ,shall be conducted by the both parties in collaboration subject to the college rules and permission of Principal.
4. The College can provide Auditorium OR Class rooms for the activities conducted by the Marathi Theosophical Federation .The Students of the College can take active part in the various activities conducted by the Marathi Theosophical Federation in the college campus or off the campus and also permit them to take active part in International convention conducted by Theosophical Society at Adaro Chennai India and Round Table conferences organized by various countries.
5. To design and conduct certificate, Diploma courses on universal human values in collaborations.

Responsibility of the Parties –

1. It is responsibility of the both parties to provide expert faculties and prominent speaker for seminars, workshops, Conferences and study classes and all other

activities conducted with mutual understanding

2. Marathi Theosophical Federation should provide quality material on universal values to the students free of cost for Studies..
3. Regarding financial responsibility, it is a responsibility of the party who is conducting the programmes. He must have to bear the expenditure of the programmes.


