

## Memorandum of Understanding

### Between

**Lab-X Foundation, Inc.** (a U.S Based 501-(c)-(3) non-profit organization), registered in the state of Massachusetts (Employer Identification Number: 47-2201621), having its office at 44 School Street, Suite 505 Boston, MA 02108-4209 USA and represented by its Director Mr. Ketan Dande. Hereafter designated **Lab-X Foundation** and may be referred to as a 'party' to this MOU and

**Shri Shivaji Education Society's Shri Shivaji Arts and Commerce College, Amravati 444901** is a reputed educational institute, having its office at Shivaji Nagar, Morshi Road, Amravati and represented by its Principal, Dr. R. M. Bhise. Hereafter designated **Shri Shivaji College** and may be referred to as a 'party' to this MOU

#### 1. Purpose

This Memorandum of Understanding (MOU) sets for the terms and understanding between **LabX Foundation** and the **Shri Shivaji College** to collaborate to provide opportunities for students of Shri Shivaji College to work on impactful projects scheduled to start in July 2022.

The goal of this collaboration is to create a platform where students of Shri Shivaji College can work under various projects conducted by Lab-X Foundation to get hands-on experience on industry relevant skills. The nature of these projects would be to conduct research and hands-on projects that provide innovative technological solutions to alleviate water problems in Maharashtra. Conducting such activities will impart hands-on experience, exposure and skills to students and make them industry ready.

#### 2. Activities

Some of the activities mentioned below may be conducted by **Lab-X Foundation** in pursuit of goals mentioned in section 1:

- Lab-X Foundation will provide project completion certificates to students who have satisfactorily completed the project requirements.
- Lab-X Foundation may identify and make available to Shri Shivaji College speakers for online webinars or in-person seminars for guiding students on topics related to activities of this collaboration.
- Lab-X Foundation may provide industry relevant problem statements for student projects related to water problems in Maharashtra.
- Lab-X Foundation may provide connection with industry experts for technical leadership for projects.
- Lab-X Foundation may provide connections with domestic and international organizations in pursuit of forming international collaborations.
- Lab-X Foundation shall recognize Shri Shivaji College as a 'Partner' in all activities related only to this collaboration related publications including but not limited to Lab-X Foundation website, news (print and digital), publicity campaigns, social media channels and other publicity materials.

Some of the activities mentioned below may be conducted by **Shri Shivaji College** in pursuit of goals mentioned in section 1:

- Shri Shivaji College may identify a minimum of 30 and upto 300 students for projects related to this collaboration and provide the necessary permissions for students to conduct project activities related to this collaboration.
- Shri Shivaji College may identify up to 20 faculty members to act as coordinators for this collaboration and to act as liaison between students and Lab-X Foundation staff
- In pursuit of the project related activities, Lab-X Foundation's representatives would conduct bi-weekly project progress meetings virtually with Faculty members and monthly progress meetings virtually with the Principal of Shri Shivaji College
- Shri Shivaji College may allow its students to conduct academic projects relevant to this collaboration with inputs from Lab-X Foundation regarding industry relevance of such projects.
- Shri Shivaji College shall recognize Lab-X Foundation as a 'Partner' in all activities related (only) to this collaboration related publications including but not limited to Shri Shivaji College website, news (print and digital), publicity campaigns, social media channels and other publicity materials.
- Shri Shivaji College may make available the resources such as auditoriums, A/V equipment and coordinators for the duration of the events pursuant to the goals of this collaboration.
- Shri Shivaji College may connect Lab-X Foundation representatives with the other regional Agriculture related educational institutes, Gram Panchayats and other educational institutes under the aegis of Shri Shivaji Education Society for the purposes of completing project related tasks.

### **3. Funding**


This MOU is not a commitment of funds to each other by either Lab-X Foundation or Shri Shivaji College. The students who will work on projects under this collaboration will not be provided any monetary compensation by Lab-X Foundation.

### **4. Duration**

This MOU is at-will and may be modified by mutual consent of authorized officials from Lab-X Foundation and Shri Shivaji College. This MOU shall become effective upon signature(s) by the authorized officials Lab-X Foundation and Shri Shivaji College and will remain in effect until modified or terminated by either Lab-X Foundation or Shri Shivaji College by mutual consent. Lab-X Foundation or Shri Shivaji College may terminate this MOU upon continued and sustained unsatisfactory fulfilment of expectations as mentioned section 2 by the other party at any point of time. In the absence of mutual agreement by the authorized officials from Lab-X Foundation and Shri Shivaji College for further continuation, this MOU shall end on August 1<sup>st</sup> 2023.
